ASSESSMENT SYSTEM AND CRITERIA

1 ORDINARY EVALUATION

Elements of the applied system of assessment:

1 Applied proof about acquired knowledges: Two multiple-choice test for evaluating of the capacity of understanding about the essential elements of the subject. It involves 10% of the mark.

2 Individual work: every student should prepare one course dissertations. Contents: summary about the key elements, concepts and applications of the main concepts offered in classes, mind-maps



and sketches, personal reflexions and mini-essays. The goal is to assign the competencies of the subject in a global manner. It involves 30 of the final mark.

3. Applied works. There will be 3 compulsory exercises that will be described along the course. One related to the concept of person, another on the business ethics or social corporate responsibility, and another on some texts of the Christian Social Thought related to economics. It involves: 30% of the total mark.

4. Final proof: written exam, mainly connected with the essential points of the programme. It will be a short version in the case the student had done the practical exercises and the dissertation In this case it involves 30% of the final mark. In other cases, it will be a longer exam and it involves 100% of the final result but the maximum mark will be 7 points because basic and general skills could not be assessed .

Continuous assessment: requirements.

- 1 75% of class attendance
- 2 An assessment of at least 5 points in the final proof.

#### 2 EXTRAORDINARY EVALUATION

1 Exam: it includes the same elements than the Final proof in the Ordinary Evaluation. It involves still 100% (without continuous assessment) or 75 % of the final result.

2 The students having obtained an evaluation through continuous assessment can maintain still a 25% of the final result.
